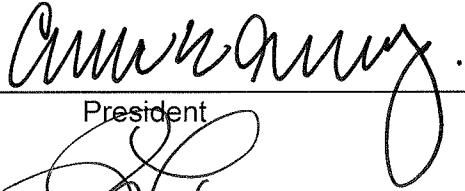

**AMENDMENT TO DECLARATION OF COVENANTS,
CONDITIONS AND RESTRICTIONS**

Article XI, of the CC&Rs "Use and Occupancy of Units and Common Area" is hereby amended to add the following language as Section 34:

Section 34. "Assignment of Common Area Garage Storage. The Association, through the Board of Directors, shall have the authority to assign certain non-deeded common area storage spaces in the garage to owners as their exclusive use, in accordance with Civil Code Section 4600 (b) (3) (G). This section shall not apply to any storage space that already is assigned to the owner of a separate interest by deed."

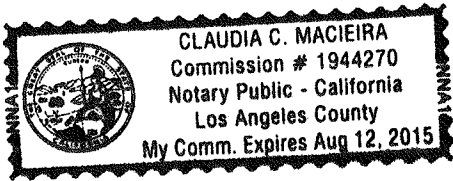
